

Chapter 8

Regulations, Orders and other Bye-laws in Operation : Alphabetical Order

8. An Overview of the Chapter

The first section of this chapter contains Regulations framed under parent laws.¹ As a general principle, Rules making power is vested to the Ministry under whose ambit the laws fall while Regulations making authority² is vested to the autonomous bodies, such as a directorate, corporation, etc. The Regulations framed by various such authorities have been presented in Alphabetical Order in this chapter. The total number of Regulations presented in this chapter stands at fifty nine.

Apart from conferring Rules and Regulations making power, many parent laws empower Ministries and other bodies to frame Order, needless to say, these orders are bye-laws.³ The total number of Orders which the author able to trace and present in this chapter stands at fifteen.

The last section of this chapter presents some bye-laws which are not known as Rules, Regulations and Orders but fall into the same category of

delegated legislation i.e., framed in accordance with the authority given by specific parent laws to that effect. The authors have presented only three such bye-laws.

It may be pointed out that no official effort has so far been undertaken to collect and publish Regulations and other bye-laws in a systematic manner. Hence, the authors had to look for and collect them from diverse sources. Thus, the list of Regulations, Orders and other kind of bye-laws presented in this chapter may not be exhaustive.

Chapter 9

Repealed and Suppressed Rules, Regulations and Orders

9. An Overview of the Chapter

Rules, Regulations and Orders are either repealed or suppressed.¹ Rules, Regulations etc., are repealed in two ways, first due to the parent law being repealed, if not otherwise saved, by the 'savings clause' of the repealing law.² Second by the simple method i.e., repealed by a subsequent Rules, Regulations etc., on the same issue or subject. There exist many Rules, Regulations and Orders, which are issued in such a manner that they do not repeal the earlier ones on the same issue or subject but merely suppress³ the former ones.

This Chapter lays down only those repealed and suppressed Rules, Regulations and Orders which the authors have been able to locate.⁴ The
